MINUTES - POSEN TOWNSHIP - 06/10/10

REGULAR MEETING OF POSEN TOWNSHIP BOARD HELD AT TOWNSHIP OFFICE JUN. 10, 2010 STARTING AT 7:00PM. PRESENT WERE: JAMES ZAKSHESKY, JUDY SZCZEROWSKI, DARLENE POLASKI, FRANK BUDNIK AND DAN BUZA. LORRAINE SMIGELSKI WAS GUEST.

MINUTES WERE ACCEPTED AS PRESENTED. MOTION BY DAN, SECOND BY DAR, AYES ALL.

FINANCIAL REPORT WAS ACCEPTED AS PRESENTED. MOTION BY DAN SECOND BY DAR AYES ALL.

**AMBULANCE BOARD:** JIM REPORTED THAT AMBULANCE RUNS ARE LOW, WITH THE RESULT OF INCOME DECREASE. IN SPITE OF THIS, THE AMBULANCE BOARD IS DISCUSSING LOWERING THE MILLAGE FOR NEXT YEAR FROM .7 TO .65 OR .6. THEY ARE ALLOWED TO LEVY UP TO 1.0 MILLS.

**FIRE BOARD NEWS :** JIM REPORTED THAT THE FIRE BOARD IS NOT CONSIDERING ACQUIRING A NEW BUILDING AT THIS TIME. THE MONIES GENERATED BY THE CURRENT MILLAGE WILL JUST BE ENOUGH TO PAY FOR THE TRUCKS AND COVER THE CURRENT BUDGET.

### **NEW BUSINESS.**

JIM ASKED THE BOARD TO APPROVE PATCHING THE PARKING LOT HOLES. MOTION BY DAN, SECOND BY DAR, AYES ALL. WORK WILL BE DONE BY THE P.I. COUNTY ROAD COMM.

SNOW MOBILE TRAIL CONVERSION TO SEASONAL HIKING AND BIKING TRAIL. QUESTIONS ARE STILL PENDING REGARDING THE EFFECT THIS WOULD HAVE ON HUNTING IF THE TRAILS ARE OPEN TO HIKING. MORE NEWS LATER.

DARLENE REPORTED THAT THE \$9000 LOAN FROM SAVINGS TO TAX ACCOUNT HAS BEEN RETURNED TO SAVINGS.
